5.	Alney Practice Update (IP)	
	COVID vaccinations Plans	
	 Currently just an expression of interest needed from the practice but it will be a quick turnaround from when plans are announced to when jabs are given 	
	• First cohorts will be carers, 80+	
	 Primary Care Network (PCN) are planning so clinics will be held at Churchdown Community Centre 	
	• There will be separate planning for those that are housebound	

•	Vaccine needs a freezer that stores at -70/80 degrees C and cannot realistically deliver this to every location; therefore one central HUB.	
•	There will likely be an allocated day for first cohort. Patients to be invited via letters/phone calls etc.	
٠	Vaccination is two jabs so we will then need to invite for second dose. Some people may not have this out of choice	
٠	Details are currently sketchy and no vaccine has yet been approved (Post Meeting note: now has been approved)	
•	Talk of Imjin Barracks/fire station volunteers- if help is required and this is fed to me by clinical director of PCN, then I will approach the PPG members	
Flu V	accinations Update	
٠	We have now jabbed 72% of plus 65's;	
•	New cohort age 50-64 can have jabs from 1 st December	
•	Additional Saturday clinics (December 12 th) at Highnam and Cheltenham Road site for this but for any others that haven't had yet also. Around 600-700 appointments available between the 2 sites but we can order more jabs and extend numbers if demands require it. We have enough clinicians ready to do this	
Econ	sult Update (to include accessing appointments)	
•	Yet to make a practice decision on whether to go ahead with this but have put on hold during COVID vaccinations and flu vaccinations etc. We have received some feedback to not take on. Will ask for more feedback and relay to Katherine Holland	
Pract	tice Staff Update	
•	Rachael Banfield: started in her role for the PCN as Social Prescribing Link Worker	
•	Chloe Ann Renouf Baldwin: new lead receptionist- already looked into making changes to try and make more routine appointments available/ other processes. Also work such as new blinds on reception at Cheltenham Road site etc. We are looking at creating a triage list which allows for correctly signposting so things that do not need to go a GP are prevented from doing so leaving them with more time for urgent matters	
•	We have a new section on wellbeing part of the website where you can use your postcode to find services closer by to you	
•	New Practice Nurse: Sarah Rochester starting on 7 th December but initially shadowing so will be early January before having her own clinics

	POST MEETING NOTE: A few months ago, EMIS Web I(the Practice Clinical System) advised the Practice to de-activate this feature because patients were able to see the letters before the GP could. EMIS are still working in a fix and will advise when the fix has been applied. Then Ilyas will re-activate the feature	
	c) Improving outdoor queuing at the Highnam Surgery: use of gazebos suggested. IP will pursue this.	IP
	d) Are additional services still being offered at the Alney Practice eg Cryotherapy ? IP said he would make enquiries	
	POST MEETING NOTE: IP confirmed the Practice does provide Cryotherappy but only for pre-cancerous conditions. If it is not cancer, then this would have to be done privately	IP
	e) JB asked about the response given by the Practice receptionist etc when they answer the phone. IP It agreed that receptionists answering the phone should give the name of the Practice followed by their first name
